Notice Concerning Changes in Parent Company and  
Specified Associated Corporation at the Asset Manager

Oedo Onsen Reit Investment Corporation (the “Investment Corporation”) announces that there will be changes in parent company and specified associated corporation of the company to which the Investment Corporation entrusts the management of its assets, Oedo Onsen Asset Management Co., Ltd. (the “Asset Manager”). Details are as follows.

1. Background to the changes

The Asset Manager has received a notice to the effect that for the purpose of improving organizational efficiency, K.K. BCJ-29, a wholly owned subsidiary of K.K. OOM Investments, and K.K. OOM Investments (Note) decided and executed on May 23, 2022 an absorption-type merger in which K.K. OOM Investments becomes a company surviving the absorption-type merger and K.K. BCJ-29 becomes a company absorbed in the absorption-type merger, with an effective date of July 1, 2022.

As a result, while K.K. OOM Investments continues to fall under the category of the parent company and specified associated corporation of the Asset Manager, K.K. BCJ-29 ceases to be the parent company and specified associated corporation of the Asset Manager.

Meanwhile, even after changes in the parent company and specified associated corporation of the Asset Manager, the management of the Asset Manager remains unchanged and therefore no modification will be made to the Asset Manager's policies for investment, asset management, etc.

(Note) G.K. OOM Investments implemented an organizational change on May 27, 2022 to increase social credibility and became K.K. OOM Investments.

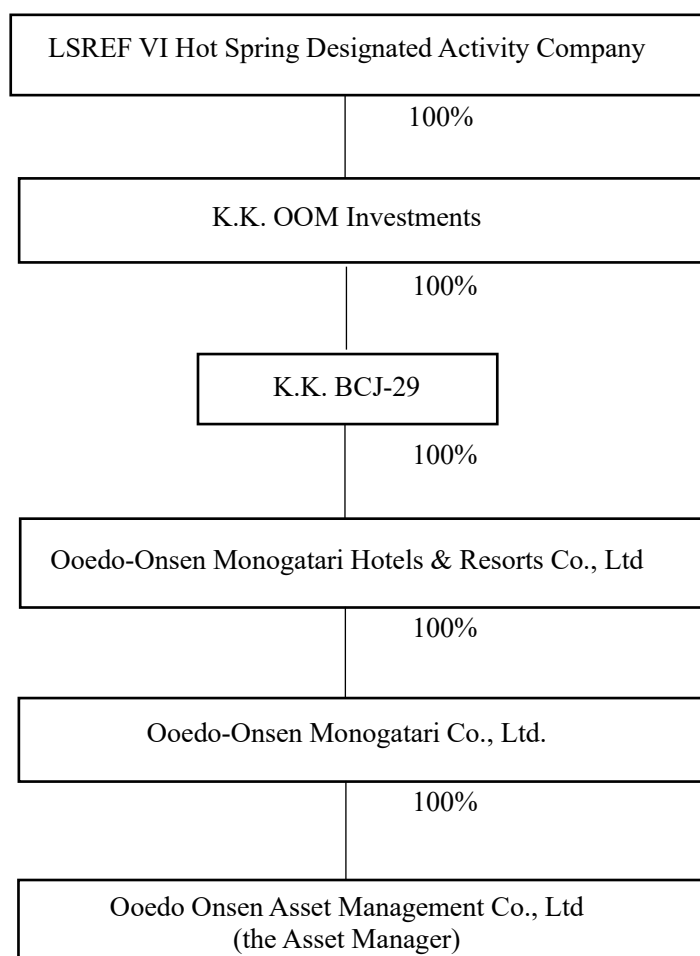
